THIS WINE IS MADE OUT OF NEGROAMARO AND CABERNET SAUVIGNON GRAPES COMING FROM BUSH-TRAINED ESTATE VINEYARD PLANTED WITH THE ANCIENT "SETTONCE" SYSTEM."
