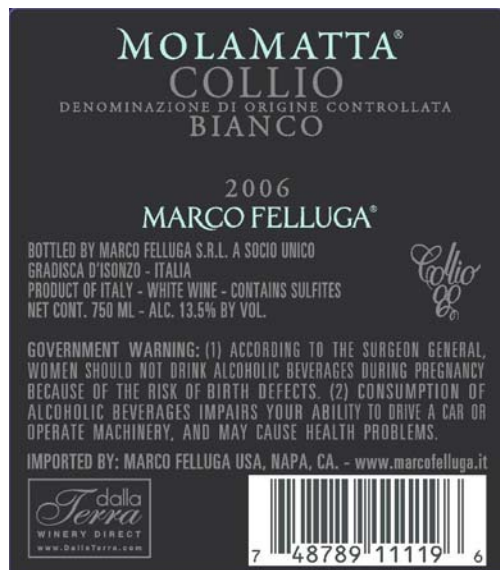
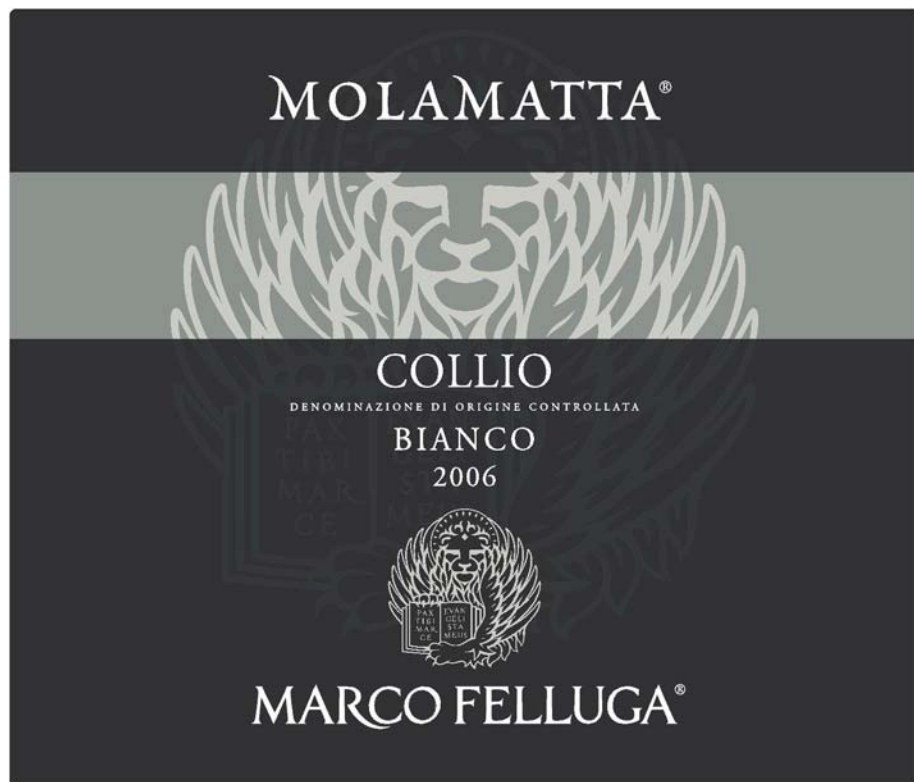


Image Type: Back
