Alessandro Piangiamore was born in Enna in 1976. The synthesis of his thinking clearly expresses itself in the inspiration within the artwork reproduced on the label: "in my work I always try to crystallize the ephemeral through a practical approach to the matter; this enables me to adhere to reality and understand it". The balance between physicality and abstraction, nature and artifice in his work always maintains an intimate and poetic dimension that often leaves to chance the state of the final shape.

This Barolo is made from grapes grown on the "Villero" vineyard in Castiglione Falletto. It is only produced in special vintages, and it becomes "Riserva" after a long time ageing in oak and in bottle.
